SFWD Needs Your Help Verifying Lead and Copper Water Lines

The District is conducting an inventory of our service lines to comply with current EPA standards as they pertain to lead and copper material used in legacy lines. This mandate includes reviewing and inventorying public and private lines; therefore, your in-home water lines are part of this program.

SFWD is close to completion on the inventory of lead and copper lines in our area, yet we may need to verify the service material in your home...and we'll need your help.

BACKFLOW DEVICE TESTING

Backflow testing is critical to the protection of our public water supply. Every irrigation system installed in Nassau County must include a backflow device that gets tested annually. SFWD has been providing this service to its District residents free of charge since the requirement was mandated by Nassau County Department of Health since the early '90s.

The average test from a private backflow tester costs \$70. This provides a significant savings on a mandated regulation for our customers.
